Position	Directing Attorney – Family Law Unit (Full-time)
Organization Description	The Public Law Center (PLC), Orange County's non-profit <i>pro bono</i> law firm, is committed to providing access to justice for low-income residents. Through volunteers and staff, PLC provides free civil legal services, including counseling, individual representation, community education, and strategic litigation and advocacy to challenge societal injustices. Now in its 37 th year of service, PLC works with more than 1,600 volunteer lawyers, paralegals and law students from throughout the county who volunteer their time and expertise. The Family Law Unit provides assistance in the following areas: Orders of Protection in Domestic Violence cases, Divorce or Parentage petitions, Child Custody/Support/Visitation and Guardianships along with Special Immigrant Juvenile Status (SIJS). The Directing Attorney would be expected to provide assistance in these areas through direct representation to clients, general <i>pro per</i> assistance at clinics, guiding and mentoring lesser experienced staff attorneys and providing technical assistance to our pro bono volunteers.
