Innovative Legal Check-up Program Serves HIV/AIDS Clients

In Orange County, nearly 4,000 people are currently living with HIV/AIDS. Since 1993, the Public Law Center (PLC), through the AIDS Legal Assistance Project (ALAP), has been the sole provider of comprehensive legal services to this community. While ALAP has been extremely successful in making inroads against the myriad legal issues raised by the pandemic, PLC desired to implement a more preventive approach to its provision of legal services. Through its new staff member, Equal Justice Works (EJW) Fellow, Alexis McLeod, PLC introduced the Legal Check-up (LCU) program in September 2007.

The LCU is an innovative approach to serving the population afflicted by HIV/AIDS, whereby a legal advocate and client proceed through a series of diagnostic questions designed to pinpoint potential legal issues, referred to as "legal soft-spots". The underlying rationale of the Legal Check-up is that by proactively identifying and addressing existing and potential legal issues before they reach crisis levels, the program facilitates the mental well-being of clients, thus encouraging immunological health and

prolongation of life. Further, by counseling clients on confidentiality, the program helps to avoid discrimination and lessens the impact of HIV/AIDS stigma, thereby facilitating the educative and preventive efforts of other AIDS service providers in the community. Recent epidemiology of the disease in Orange County shows a sharp increase among women and minorities, who face a disproportionate burden of the epidemic. In combination, HIV/AIDS and poverty often pose seemingly insurmountable legal dilemmas, further highlighting the need for early preventive efforts.

The genesis of the LCU concept is owed to the joint effort of the HIV/AIDS Legal Services Alliance (HALSA, Inc.) and the L.A. City Attorney's Office who instituted the project in 1997. More recently, the ABA Young Lawyers Division selected the HIV Legal Check-up as its annual project in 2005. The necessity of programs such as the LCU became even more evident when, in 2001, the U.S. Centers for Disease Control and Prevention (CDC) advised that people who test positive for HIV should be immediately referred to legal services. This unprecedented recom-

mendation underscores the challenges faced by people living with HIV/AIDS, as well as the important role that attorneys can play in helping these individuals and stopping the spread of the disease.

Preventive law, through the Legal Check-up, is a means of accomplishing the CDC's goals of curtailing the onset of AIDS, slowing the spread of HIV, and increasing the welfare of both those living with HIV/AIDS and the community at large.

LCU clinics are housed in various HIV/AIDS service providers' locations throughout Orange County, the first of which took place in March at REACH (housed in the OC Health Care Agency). The support of partnering organizations such as AIDS Services Foundation (ASF), Shanti Orange County, REACH, and the Laguna Beach Community Clinic have been vital to the successful implementation of this novel approach to addressing legal issues. It is hoped that through the LCU clinics, a larger segment of the HIV-positive population will receive much-needed legal services.

Funding for McLeod's salary and the implementation of her LCU project is made possible by the *Morrison Foerster Foundation* and *Equal Justice Works*. EJW's mission is "to develop the public interest law leaders of the future, whether they continue to work in the nonprofit arena or become pro bono advocates in the private bar." PLC thanks *Morrison Foerster* and EJW for serving as a catalyst to the more holistic and comprehensive provision of services to those living with HIV/AIDS.

From the Executive Director



Years from now, people may still disagree as to what to call the current economic downturn. I'll leave it to the economists, politicians and historians to determine whether we're in a recession or not. But whatever you choose to call it, the cur-

rent economy is not good. The sub prime mortgage crisis has everyone worried as credit becomes tighter, foreclosure rates increase and everywhere you look there's more bad economic news. Gas and food prices have climbed to record highs. Few among us are not feeling the pinch of the bad economy

For low-income people, the news is particularly grim. Credit is harder to obtain, jobs are harder to find and the pressures to keep a roof over one's head is all the greater. Government programs that assist the poor are facing record cuts as our State struggles with its budget crisis. And charitable organizations face tougher times raising necessary funds as donors look anxiously to an uncertain future.

Even what was intended as good news, in the form of economic stimulus, had bad, unintended consequences. The Federal Reserve Board's action to cut the Federal Funds Rate on March 18 by three-quarters of a point, while generally viewed as good for the economy, was terrible news for the California Interest on Lawyers Trust Account (IOLTA) program.

IOLTA is one of the principal sources of funding for organizations like PLC which provide free legal services to low-income persons. In that single day, it's estimated that the Fed's action cost the California IOLTA program \$8.8 million of potential revenue. That \$8.8 million in lost IOLTA revenue amounts to about a \$125,000 loss of funding to PLC.

Fortunately, our funding at PLC is well diversified so what might have been devastating news is only troubling. More importantly, our support from the Orange County community remains as strong as ever. This year's Annual Fund Drive raised more to support our efforts to provide access to justice than ever before. And so far, support for our July 14 Volunteers for Justice Dinner is strong. We're hopeful that we're able to reach our budget goals although the worsening economy means that in order to keep pace we need to exceed our initial goals. If you've already made your pledge we thank you; if you haven't, look for our invitation coming in the mail soon! And our volunteer lawyers, paralegals, law students and others continue to volunteer in incredibly generous fashion. In 2007 alone over 700 volunteers provided over 26,000 hours of free legal services to PLC clients.

That's all critically important, because the current economic situation — whatever you want to name it — is expected to increase the demand for our services to record levels. Our ability to provide access to justice is directly related to the willingness of those in the community to provide financial and volunteer support. Can we count on you to answer the call?

Legal Aid Association of California Annual Family Law Conference





The Legal Aid Association of California held its annual Family Law Conference at the Los Angeles Convention Center on February 19 and 20, 2008. *Cynthia Holton*, Public Law Center Staff Attorney, served on the Conference Planning Committee along with a number of other attorneys from legal aid associations based in northern and southern California. Ms. Holton planned the plenary session presentation on "Handling Move-Away Cases in the Public Law Setting." *Leslie Shear*, Attorney at Law, and the *Honorable Thomas Trent Lewis* of the

Superior Court of California, County of Los Angeles Central District spoke on move-away issues in the public law setting. A live demonstration highlighting important aspects of a move-away case in court followed. *Steve Hittelman*, attorney at Minyard Morris, *Yolanda Omana*, staff attorney at the Legal Aid Society of Orange County, and Ms. Holton gave closing arguments based on a move-away fact pattern emphasizing the elements of current case law that must be weighed by the judge deciding a move-away case.

PLC's work is life-changing for thousands of children, families, adults and seniors each year. Recent PLC Cases

Dan Robinson of O'Melveny & Myers assisted two victims of human trafficking in petitioning for immigration relief by filing T visa petitions. The female clients are a Vietnamese and Chinese national who were living in Singapore when they were recruited by a friend to come work in the U.S. at another friend's massage parlor. The clients came to the U.S. and were terrified when they discovered that the massage parlor was actually a front for a prostitution ring and that they would have to have sex with the parlor's customers in order to pay back a debt to their traffickers. The clients had their passports taken from them by the owner of the massage parlor, were constantly monitored, and forced to work 14 hour days, 7 days per week at the parlor. Eventually law enforcement raided the massage parlor and identified the women as victims of human trafficking. Law enforcement contacted the Orange County Human Trafficking Task Force, who referred the victims to PLC. The client's cases were screened and placed with **Dan Robinson**. One client has already received her T visa approval and work permit. She is now building a new life for herself in the U.S., including getting a driver's license, taking English classes, and working as a manicurist.

Tarzana-based sole practitioner Steven Simons represented a 74-year old woman who suffers from Alzheimer's in a collections lawsuit. This action arose out of an alleged debt of \$11,585 the client owed to a receivables management company. Simons informed the debt collector that the client was a victim of identity theft and over the next three months made numerous calls requesting proof of the debt. In spite of knowledge of the identity theft and the disputed nature of the debt, the debt collector ignored the proper legal processes and continued to pursue the lawsuit by entering a default against the client. The court ultimately dismissed the entire action. The plaintiff was ordered to pay a statutory penalty to the 74-year old woman.

A **Latham & Watkins** team led by supervising partner Jon Anderson, associates Melinda Luthin and Jason Liliestrom, and paralegals Rob Dickson, Adriana Gonzalez, and Kanita Nandhavan, represented a 40-year old single woman with two minor children in an eviction case. The matter arose from ongoing harassment of the client and her daughter from a neighbor. After one incident, the client first approached the apartment manager asking for assistance. The apartment manager suggested the client call the police. Based on this advice, the client called the police and filed police reports for each of the incidents. Following the filing of the police reports, the client was served with a Notice of Eviction. The **Latham** team successfully worked with opposing counsel to have the case dismissed. The client said that the tenants in her apartment complex have faced many evictions, and yet no one had ever successfully defended an eviction. Melinda Luthin remarked that sometimes, all it takes is representation to make sure everyone gets his or her fair chance in the legal system. 🔨

To encourage economic and social development through self employment, the free workshops compare and contrast the various forms of California business organizations, discuss practical considerations to take into account when starting a micro-business, and provide a wealth of information on resources that are available in Orange County to aspiring entrepreneurs. With a long-standing commitment to pro bono and community service work, Dechert attorneys continue their partnership with PLC to offer one-on-one counseling to workshop attendees. To date, the workshops have been held at Santiago Community College District and Westminster Public Library.
